

# Bidding instructions

To bid on a single lot, simply write in your bid amount and complete the bottom portion. To bid on several individual lots, write in your bid amount for each lot and complete the bottom portion.

If you have bid on more than one lot, you should also bid them as a group. For example if you bid on Lot 1, Lot 2, and Lot 3 at \$5,000 for each one. You should also bid them as a group lot near the bottom. It would look like this:

I also hereby offer to pay \$15,000 for the combinations of lot numbers Lot 1, Lot 2, and Lot 3. Your combination lot offer may be higher or lower than your individual lot offers as a total. This will allow you to compete with other combination offers, and also as individual lots.

There are two combination lot offers in the combination section, both will be considered on an "OR basis" at the discretion of the seller. This allows you to have two different combination lot offers on the table. For example, you could bid \$100,000 for lots 1-19, and also be able to bid a combination of \$75,000 for lots 1-18.

Once you have won a lot(s) the transaction is final, all items are sold as is as shown. 5.5% Wisconsin sales tax must be added to bid amount and paid to seller, or a valid tax exempt resale certificate must accompany the final payment.

Your bid is final, and you will not have the opportunity to raise it once you submit it. If your offer is accepted this becomes a legal and binding contract. The winning bidder will be charged 5% over the second place bid, up to their winning bid amount. Full payment via cashiers check must be paid to Skipper Bud's by Friday March 27<sup>th</sup>, 2009.
